It is suitable for recessed mounting in modular suspended ceilings: designed to suit concealed fix 'Z'systems, but will also accommodate exposed lay in-grid for either 24mm or 15mm 'T' section. The units have an all welded Zinc coated steel rear body finished in white polyester powder coat and a frosted toughened glass diffuser held against zinc coated steel frame by silicone gasket seal with stainless steel security screws. Integral fixed output or DALI compatible electronic control gear on removable hinged gear tray with fused connector block, ceramic terminal block and low smoke zero halogen cable. Integral Emergency versions also available.

  - Provide TfL at least 12 (twelve) months notice of its intention to discontinue supply or to provide such notice as is reasonable if such discontinuance is outside its control and will offer the opportunity of a Last Time Buy to TfL together with date for last order placement and supply of the parts affected.   - Provide further copies of operating and maintenance manuals to purchasers / users of the product as necessary (including certificates of conformance, calibration etc).
  - Provide further copies of training manuals and an appropriate level of training to purchasers or users of the product as necessary.
